

Draft measure

The Commission proposes to add the following to the list of companies, undertakings, institutions or entities that are both located, registered or incorporated in the Federal Republic of Yugoslavia, with the exception of the Province of Kosovo and the Republic of Montenegro, and not included in the definitions of the Governments of the Federal Republic of Yugoslavia and of the Republic of Serbia of Article 1 of Regulation (EC) No 1294/1999, under the conditions set out in Commission Regulation (EC) No 1440/2000.¹
