HIGHER COURT OF BELGRADE, Judge for the previous Court Decisions Milos Labudovic, in the criminal case against the accused Dubravka Djordjevic and others for the criminal act of the Abuse of position of responsible person in prolonged period, Article 234, Section 3 related to the Section 1, Article 33 and 61 of the Criminal Law and at the request for the investigation of the Higher Public Prosecution in Belgrade, Criminal Charges No. 162/11 from March 02, 2011 in conformity with the Article 253 of the Law on Criminal Procedure related to the Article 603 of the Law on Criminal Procedure that is applicable from October 01, 2013, makes on July 18, 2016 the following

DECISION

Against

The accused Dubravka Djordjevic, Personal ID 3012978895017, father's name Tomislav, mother's name Natalija, born Nikitovic, born on December 30, 1978 in Sremska Mitrovica, residing at Novi Sad, address Turgenjeva , citizen of the Republic of Serbia and the Great Britain, by profession Graduated Economist, civil status free, have no children and has never been convicted for any crime.

The accused Djurdja Prica, Personal ID 1110965355638, father's name Sava, mother's name Kata, born Hajdukovic, born on October 11, 1965 in Otocac, Republic of Croatia, residing in Novi Sad, address Sentandrejski Put 138, citizen of the Republic of Serbia by profession Graduated Economist, civil status free, have no children and has never been convicted for any crime.

The accused Maja Steger, Personal ID 3105963805036, father's name Valentin, mother's name Sofija, born Trbojevic, born on May 31, 1963 in Novi Sad, residing in Novi Sad, address Narodnog Fronta 76/7, citizen of the Republic of Serbia, by profession Graduated Economist, civil status free, have no children and has never been convicted for any crime.

The accused Sasa Krajnovic, Personal ID 1508977330022, father's name Aleksa, mother's name Ruzica, born Djurcic, born on August 15, 1977 in Zagreb, Republic of Croatia, residing in Novi Sad, Petrovaradin, address Prote Mihalcica 12, citizen of the Republic of Serbia, by profession Chemical Technician, civil status married, father of one minor child, has never been convicted for any crime.



The accused Mirjana Lagator Sebek, Personal ID 2409963715083, father's name Nikola, mother's name, born on September 24, 1963 in Belgrade with last reported residence in Belgrade, address Ljubomira Ivkovic Suca 34/4, citizen of the Republic of Serbia, by profession Master of Economics without other and no data of previous convictions.

DECISION ON SUSPENSION OF INVESTIGATION

That was initiated against the accused Dubravka Djordjevic, the accused Djurdja Prica, the accused Maja Steger, the accused Sasa Krajnovic, the accused Mirjana Lagator- Sebek and against whom the inquiry was conducted at the request for inquiry of the Higher Public Prosecution in Belgrade Criminal Charges No. 162/11 from March 2, 2011, on the grounds of criminal act of the Abuse of position of responsible person in alliance with others over prolonged period in conformity with Article 359, Section 3 related to Section 1, related to Article 33 and Article 61 of the Criminal Law detailed in the request for investigation of the Higher Public Prosecution in Belgrade, Criminal Charges No. 162/11 from March 2, 2011 and which in conformity with the provisions of the Articles 21 and 35 of the Law on Amendments of the Criminal Law that came into force on April 15, 2013 is modified regarding legal qualification into the criminal act of the Abuse of position of responsible person from the Article 234, Section 3 related to Section 1 of the Criminal Law, enacted by the Higher Public Prosecution of Belgrade Criminal Charges No. 162/11 from May 30, 2013,

due to the suspension of the further criminal prosecution the Deputy of the Public Prosecutor of the Higher Public Prosecution of Belgrade, Criminal Charges No. 162/11 from July 7, 2016 against the accused Dubravka Djordjevic, the accused Djurdja Prica, the accused Maja Steger, the accused Sasa Krajnovic, the accused Mirjana Lagator- Sebek for the stated criminal act.

The costs of the criminal proceedings will be covered by the budget of the Court.

Explanation

At the Higher Court of Belgrade in the proceedings against Tomislav Djordjevic at the decision of the Investigation Judge from July 14, 2011, the accused Dubravka Djordjevic and accused Djurdja Prica at the decision of the Investigation Judge from September 13, 2011, the accused Maja Steger and accused Sasa Krajnovic in conformity with the Decision of the Investigation Judge from September 14, 2011, the accused Mirjana Lagator- Sebek at the decision of the Investigation Judge from October 4, 2011 the investigation was conducted on the basis of the reasonable doubt that they committed one criminal act the Abuse of position of responsible person in alliance with others over prolonged period in conformity with Article 234, Section 3



related to Section 1 of the Criminal Law and at the request of the Higher Public Prosecution of Belgrade, Criminal Charges No. 162/11 from March 2, 2011, specified on May 30, 2013.

Against the accused Tomislav Djordjevic by the decision of the Higher Public Prosecution of Belgrade Criminal Case Proceedings No. 43/14 from July 28, 2016, the case of the Abuse of position of responsible person in alliance with others over prolonged period in conformity with Article 234, Section 3 related to Section 1 of the Criminal Law is suspended on the grounds of the death of the accused.

After the investigation supplement on February 23, 2016 the Judge for the previous case submitted all documents of the Case 43/14 to the Higher Public Prosecution of Belgrade for further consideration.

Higher Public Prosecution of Belgrade by the report related to the Criminal Charges No. 162/11 from July 7, 2016 informed the judge for the previous case that the further criminal prosecution is suspended against the accused Dubravka Djordjevic, the accused Djurdja Prica, the accused Maja Steger, the accused Sasa Krajnovic, the accused Mirjana Lagator- Sebek for the criminal act of the Abuse of position of responsible person in alliance with others over prolonged period from Article 234, Section 3 related to Section 1 of the Criminal Law.

Since the Higher Public Prosecution after the investigation completion suspended further criminal prosecution of the accused Dubravka Djordjevic, the accused Djurdja Prica, the accused Maja Steger, the accused Sasa Krajnovic, the accused Mirjana Lagator- Sebek for the criminal act of the Abuse of position of responsible person in alliance with others over prolonged period from Article 234, Section 3 related to Section 1 of the Criminal Law the Judge for the previous case decided as above in conformity with the Article 253 of the Law on Criminal Procedure related to Article 603 of the Law on Criminal Procedure enacted from October 1, 2013.

Taking into consideration that the criminal prosecution of the accused is suspended the Court in conformity with the Article 197 of the Law on Criminal Procedure related to the Article 193 and Article 194 of the Law on Criminal Procedure decided that the costs of the criminal proceedings would be covered from the Court budget.
